BUTCH IS LOOKING FOR A REPLACEMENT

The Quarter Century Club is looking for a few good men or women. To be more specific, I'm looking for several candidates for the office of QCC State President, a volunteer position. To prove that I mean business, I'll put my money where my mouth is and commit up to \$500 of my meager personal wherewithal (not QCC funds), to support that search.

I have served in this office since March of 2004, over seven years, far longer than the QCC Constitution allows, (2 years maximum). I was not 'elected' in a real election, but rather invited and given the job after being confirmed by the other statewide officers. That same 'appointment' process has been used to fill state

office positions five other times during the course of my extended term. While not the optimum process, it has been the only expedient means if only one person stepped up to the job, but it has filled positions without the voice of our members.

I have repeatedly invited QCC District Directors to advise of potential candidates for President that they thought were competent and willing to take on the task and have come up empty, so I'm bringing my request to all of our members.

I'd like to change the 'appointment' process with an election for a new President. To encourage several potential candidates to compete for the office, I'll offer a \$100 bill to up to five candidates who will abide by my nomination process.

Anyone may submit a nomination in line with the QCC Constitution, but to qualify for the extra \$100 bonus I'd like to include some additional requirements.

Candidates must include written endorsements from their District Director and four other current

members to qualify for the \$100 prize. Only one candidate will win the election for the title of President, but up to five members can win the \$100 award for being a candidate with the five endorsements as specified above.

This is a good time for a change in leadership as the QCC has recovered from our financial crisis by raising the

dues and cutting our printing costs. We should now have a surplus at the end of the year.

Another reason that the timing is right is that some very competent people currently fill the other State office positions with high expectations for them to continue in their positions for some time.

But wait, there's more. A helpful guide to explain the roles and duties of the State office holders has been developed and is available upon request.

But wait, there's more. A new item for this year is



that Districts will be allowed reimbursement from the QCC State treasury for some of their recruiting costs as well as the cost of contacting current members, so I look for our membership to rebound with lots of fresh new talent.

Your help is greatly appreciated in bringing a few new and capable candidates up for a real election for a new QCC President. I thank you in advance for what you can do to help.

Marie Martin wrote of a brush fire near her Tujunga residence: "I was running errands in the car on Foothill Blvd. when the radio news came on to say a brush fire had already spread to 5 acres on the ridge above the 11000 block of Tujunga Canyon Blvd. It took a moment for me to tune in mentally to the fact that... HOLY Bleep! That's where I live! My two dogs, Frankie the cat, and [a friend's] collie Shelby were all at the house. Traffic was just crawling along Foothill and I was insanely trying to hurry home."

"When I got near the house, fire trucks were blocking everything. I asked the firemen if I could leave my car on the road and go get my dogs. They said I would be blocking them for getting out if I didn't come right back. So I ran up and leashed up the canines. Frankie was nowhere to be found. When I got back to the car, I could see burned chaparral and the white stuff the helicopters dump on fires. There were scads of fire trucks, firefighters, and prisoners in their bright orange jumpsuits, all hosing and clearing brush. The prisoners near the road were fascinated with Bismarck because he's such a big dog."

"They knocked down the fire really fast, but today it smells smoky and looks awful. I'm mad because I missed seeing the Helicopters [and] perturbed because we're having fires already and it's only May!" [Postscript: Frankie came out after the hubbub was over].

When Marie returned to her residence in Ocean Park, Washington in July, she had more to relate: "Last night I was watching TV when I heard a sort of PssshWHOOMP! The sky was immediately lit up. I looked out in horror to see flames about 10 feet high only two houses away. I grabbed the phone and called 911. The bored operator said, 'Yes. House fire on 202 Lane.' There was another WHOOMP! and the ground shook. I yelled 'It's not just a house fire! There

are explosions, listen!' I was holding out the phone when to my horror I realized I could see a woman just sitting in front of the house only about ten feet away. It was obvious that she must be hurt or something. About five other neighbors were converging on the woman. A big guy was already vanking the fence behind the woman out of the ground. We all grabbed the woman's chair and there was another explosion. Blobs of fire were shooting out of the windows and landing all around us. The woman was very overweight; she said she couldn't walk and she had barely made it out of the house. Thank heaven that big guy was there, as it was almost impossible to carry her in that plastic lawn chair. We put her down for a minute, but there was another explosion so we struggled and got her across the driveway. She said she had ten oxygen cannisters in the house, so the explosions kept coming. The flames jumped to the garage. Someone put a blanket over the woman as it was raining. I tried to put it over her shoulder but she said her arm and leg were burned... they were black. The ambulance finally came and took her away. [Her] house is a total loss!"

Marie Martin had some fun also as she went on a Chesapeake Bay Lighthouse tour in May 2011.
