# **No Secrets Left?**

'YOUR PAY IS PUBLIC INFORMATION!'

## From the Corner Pocket

The list of pay for nearly all public employees and retirees in California has been posted online. I don't know the details on how it came to be, as one story was that CalPERS had declined requests to do so. But somehow, someone has made it available. Not all public agencies have complied with the requests and are noted as such in the listings.

Some small comfort is that, while your: name, years of service, agency retired from, year of retirement, and annual retirement benefit are listed, no other personal information is. If anyone wanted to track you down they would have to use some other means.

While the information on the web site

came to me without my actually searching for it, I'm not so sure how many others would be likely to stumble on it as easily as I did. I'm often searching the web, checking on stories of public pensions and related news. It was in that search for pension news that I happened upon that site.

You can rest easy that I will not broadcast the news of that web site. I sent out a question to over 100 Caltrans people, most of who are retired, asking their opinion weather the news of the site should be published. The response came back with the "No's"



outrunning the "Yes's" by ten to one. While that is an unofficial survey, the resounding reply tells me that most retirees prefer not to broadcast the web site information. Don't ask me to give it to you. I'm keeping the confidence that was asked of me.

We, of the lowly 'worker bee' level need not feel at all guilty of pulling down a large pension. The really out of scale ones are in various local city, county and special districts. There you see

thousands of retirees pulling down pensions running to many hundreds of thousands per year. Even without all of the higher paid local pension plans, in the group of just state employees, there were about 15,000 retirees getting over \$100,000 and less than 50 of those were from Caltrans.

Besides the large pensions of local agencies, the upper ranks of State pensions fall into categories of medical, education, legal, and police and fire supervisors. When any two categories cross, such as a prison doctor, or a law school dean, they get a big spike in pay and pensions.

Not to scare you anymore, but John Arnold, who left Enron without prosecution, and now manages a hedge fund, (no rules), has used his *Laura and John Arnold Foundation* to make a hatchet job video on public pensions. He then tried to funnel \$3.5 million through a PBS affiliate, New York City's

WNET, to give status to his piece telling how public pensions are the cause of all of our government's problems. When the truth came out, WNET had the dignity to return the bribe to try and save face.

This edition of the QCC'er has the membership roster that may be a way for you to contact your retired friends and reconnect for some more good times.

Some positive news is that, with the help of Russ Plowman D-11, we had a thorough review of the State QCC finances and they look very good. See page 18 for the 2013 Financial Report.

### **To Honorary Members**

Have you seen this option- **FREE PRINTED COPIES** on the membership renewal form? Many of you have and didn't know exactly what it was for, or thought it was just a free subscription if you checked the box. Well, here is the rest of the story.

If you are at least 80 years of age, you are classified as an Honorary member of the QCC. Being an Honorary member qualifies you for a discounted rate for the printed QCCer, or the electronic version of the QCCer for free (if you have a working email address). These dues rates are less than our cost of producing and sending the QCCer to you, so it's a pretty good deal. The other free option is for Honorary members who cannot afford the \$5 or \$10 rate and do not have a working email account. In other words, paying the dues would be a hardship for them. In this case, the QCC Constitution allows for the free delivery of the printed QCCer, **if** the Honorary member makes a confidential request to their QCC District Director, **and** the Director provides written approval. This written approval should be sent to the QCC Secretary/Treasurer.
