he inscription in the plaque below might be seen in the D-11 section, but this sterling QCC'er has earned the right to make the front page. This is a surprise story jumping up after a long hidden secret. Please give a listen to the story of a true Heroine from our ranks.

Recently, on visiting a friend at our local San Diego Sharp Memorial Hospital, a plaque in the visitors room, by a door to a private "Consultation Room # 2", read —

Donated by Cathy Groben

First let me WOW you and say that the newly renovated San Diego Sharp Memorial Hospital, completed in 2008, cost \$135 M, is a 7-story building, with 315,600 sf, (7.5 Ac for surveyors), that serves 2,600 doctors with 10 operating rooms. Something any community would be proud of.

The Star of this story is a small but mighty Lady weighing less than most teenagers, not over 5' tall who served the people of California in her role at Caltrans for many years. If you were not part of D-11 Construction you may never have heard of

her. Her quiet and humble manner did more good than headlines. But as one of the fortunate few who knew her, I saw **Cathy** with the amazing talent to help those who needed help, whenever and wherever. Her wisdom and gentle encouragement was an awesome help to so many needing to learn the processes and get their work done right.

On retirement in 1994, her abounding talent needed to find another outlet. Cathy had several

family members involved in healthcare and found her way to volunteer at local hospitals, (four of them). Cathy served in positions from Reception Desk, Lobby Concierge, Gift shop, Outpatient Pavilion and the Sharp Memorial Auxiliary Board of Directors to interface with family members, staff, patients and physicians. She attended Statewide

Volunteer Conferences representing the Sharp Auxiliary program and in April, 2006 was awarded "Employee-Of-The-Month", the first time a volunteer ever won the award normally given to paid staff. She usually worked two days a week to tally up over 5,900 hours (nearly 3 years of full-time work) of service and was awarded the prestigious "Sharp Memorial Gift of Time" by the CEO's of Sharp Hospital.

Near the completion date of the new hospital building in 2008, with advancing age and health issues, Cathy sold her home in San Diego and moved east to live near family in Indiana. After her years of service she had the means to offer one more generous gift to others by making a donation to the hospital from the sale proceeds of her home. Now her legacy of service to others will live on for many years to come.

CALIFORNIA TRANSPORTATION FOUNDATION

Congratulations to Caltrans on winning AASHTO's People's Choice Award for the Bay Bridge Project. A record 73 transportation projects from three states and the District of Columbia were nominated in this 7th annual competition. The Grand Prize (\$10,000) was to be used to support a charity or transportationrelated scholarship program of the winner's Caltrans chose the California choosing. **Transportation Foundation** (CTF) as its recipient and we thank you. The donation will be used to support the annual Workers Memorial Ceremony to be held on the steps of the State Capitol on April 16th and to create a new workers memorial plaque in the lobby of the Caltrans Headquarters building honoring those employees that have died in the line of duty.

Starting off 2015, CTF is proud to again cosponsor the annual Workers Memorial Ceremony to be held on April 16th on the steps of the State's Capitol. The ceremony remembers and honors those employees who have lost their lives while working for the safety of the traveling public with the placement of a wreath in the center of a large diamond of orange cones. Each cone bears the name of one of the 183 Caltrans employees that have been lost. It is a tribute that must be seen to be appreciated. We hope that you will be able to join us this year at any of the tributes being held, either in Sacramento on April 16th or in your own area.

The Foundation welcomes three new Directors to the CTF's Board. These new directors are Ryan Chamberlain, Caltrans District 12 Director; Michael Miles, former Caltrans District 7 Director; Andre Boutros, former Executive Director, CTC; and Eric Shen, Director of Transportation, Port of Long Beach. A special thanks goes to the outgoing Directors Ann

Olson, MRO Engineers; and Jody Jones, former District 3 Director.

2014 was a banner year for CTF. We awarded almost \$79,000 in scholarship grants. We also endowed two new scholarships, including one exclusively for children of transportation workers killed on the job, and we increased the endowment of the **Bimla Rhinehart Memorial Scholarship** to \$55,000. We helped fund three memorial signs honoring fallen Caltrans workers: **Stephen Palmer, District 11; Dean Patton, District 3; and Shawn Baker and Robert Jones, District 2.** We also established a fund to support a memorial plaque honoring **Dick Murphy,** a long time **District 7** employee.

im and Sandy Ceragioli tell us of a trip on a cruise ship in December:

We flew to San Diego and boarded the MS Amsterdam on December 8th. This started a 2 week cruise to Ft. Lauderdale Florida. Our first two days were at sea as we cruised down the coast of the Gulf of Mexico, otherwise known as Lower California. Our first port of call was Puerto Vallarta, Mexico. We, along with our travel companions Carol and Lynn, had decided prior to departure that we were going to do the ZIP LINE and so the opportunity presented itself here. We were taken to the jungle to an elevation of about 5500 feet in a Unimog which was an experience in itself. Open seating in the back with an unmaintained diesel engine able to go no more than 40MPH. It was a real jungle car. We were greeted by a group of young men and women who described what we were about to do. Then we were outfitted with harnesses that would

secure us to the line. Off we trekked to the first tele of 11 platforms. Since none of us had ever done this before, there was a bit of hesitancy to make that first zip. Our group consisted of 7 people and I was the last to go. It was interesting to note that all you do is sit down in your harness with your right hand holding the upper line behind that pulley and use that as a brake. Off you go zipping down the line to the next platform. On one zip, we were asked if we wanted to do it upside down, and Lynn and I said yes, but the girls said no. Twice, we rappelled to the ground and walked to the next platform. A fun trip to talk about many times.

Our next stop was in Huatulco, Mexico where we just spent the time in the village where the girls shopped for jewelry. **Sandy** expressed interest in a silver bracelet and then had to put up with the salesman for the rest of the day. He followed her around the village trying to get her to buy it, but she had told him what we would pay and he never came down to that price.

Puerto Quetzal, Guatemala was our next port of call. Here we went to Antigua to see a jade factory and learn about jade. I was always of the impression that jade was green. Well, come to find out that pure jade is white and only because of impurities does it get its green color. On our way back to the ship, we got caught in a local festival parade and had to wait for it to clear before progressing on. It took about 30 minutes for the parade to turn onto another street. All the people in the parade were dressed in their finest. Even the children were wearing dresses and suits.

Our next stop was in Corinto, Nicaragua where we went to see how rum was made. One very interesting thing there was that all the rum barrels came from the US whiskey manufacturers when they got rid of them. We saw barrels from Jack Daniels and Wild Turkey. We also got to taste 18 year old rum which I must say was fabulous. The company Flor de Cana is very

concerned about the welfare of their employees and their families. They pay for complete medical care and schooling for all of the children through college. I have no idea what they pay their employees but with this covered, I would guess it is low.

Next came Puerto Caldera, Costa Rica. It seems this country is rife with volcanos that are erupting all the time. There were 7 active ones when we were there. A village we went through had a church that had collapsed so many times that they decided to rebuild it with iron. It has been up for over ten years now. We went to an ox cart factory where the entire factory operates with water power. Very quiet manufacturing.

We then traveled to Panama where we entered the canal. Very impressive construction for that facility. When we went through, the lock next to us had a container ship in it and I swear there was no more than six inches freeboard on either side of that ship. They have a very interesting method of keeping the ships from rubbing the sides. They tether the ship front and rear to donkey engines that do nothing more than keep the ship centered in the lock and into and out of the lock while the ship moves under its own power. We saw one monstrous crocodile as we exited into the Atlantic. The new sets of locks are still under construction and won't be completed until next year.

The last stop was Cartagena, Columbia. We did not get off the ship as I was suffering from an old man's disease called gout. My right big toe was so sore I could not walk and had to go see the ship doctor who gave me a shot in the butt and said I would be good in 24 hours. Then it was on to Ft. Lauderdale where we flew home to Sacramento. From **Jim and Sandy Ceragioli**

The Purple Heart Trail

In celebration of Veterans Day, and in honor of the men and women who have been wounded or given their lives in combat while serving in the U.S. armed forces, Caltrans partnered with the Military Order of the Purple Heart - Chapter 750, State Senator **Hannah-Beth Jackson**, and Ventura County Supervisor **Kathy Long**, to install Purple Heart Trail signs along US Highway 101 in Ventura. This segment is part of a larger network across the nation, and covers the length of Ventura County on US Highway 101. A 36-mile segment in Santa Barbara County was designated in 2010.

Senate Concurrent Resolution No. 27 (**Jackson**, Resolution Chapter 88, Statutes of 2013) established specified portions of US Highway 101 in the counties of Santa Barbara and Ventura for inclusion in the National Purple Heart Trail. "The Purple Heart Trail is a visual reminder of the long road that these soldiers traveled to preserve our freedom and way of life. [We] honor them with [these] designations along our highways," said Caltrans District 7 Director **Carrie Bowen**. Private donations organized by Military Order of the Purple Heart - Chapter 750, funded the cost for the signs.

The Purple Heart Trail was established in 1992 by the Congressionally-sanctioned Military Order of the Purple Heart to be a symbolic trail throughout all 50 states to commemorate and honor all men and women who have been wounded or given their lives in combat while serving in the U.S. armed forces. The Purple Heart Trail originates in Mount Vernon, Virginia, and traverses the United States to California.

Caltrans had an Air Force?

This requires some long-term memory... Remember back to 1983... That is 32 years ago... The Olympic games were in the planning stages, dire predictions of massive gridlock and tax payer bailout ran rampant. To assist with gridlock Caltrans undertook an unusual strategy – they'd actually put Caltrans employees in helicopters as traffic observers! Marie Martin

was one of those lucky few, and she shares some of her long term memories of that time with us.

Marie shares, "About a year prior to the 1984 Olympics Games, during the period in which Caltrans' involvement was being widely discussed, a rumor began to circulate that CT employees might serve as traffic observers in helicopters. This did materialize and I was fortunate to be one of those observers. It was a highly innovative and very successful group effort!"

"Rumors circulated wildly that we might be unpaid volunteers, paid straight time, or overtime, or be on our own time, etc. Other rumors included, that each observer would fly only once, only Seniors would be chosen, various life and medical insurances would be null and void if we flew, we would all have to be commercial pilots wearing Nomex flight retardant suits, and the helicopters would all be from the Army! Ultimately, none of them turned out to be the case, we were paid overtime, and the day's work often ran 12 hours or more."

"While 100+ Caltrans employees turned out for the initial meetings, it became clear that we would be 'on call' 24 hours a day, have essentially no time off - including weekends - for a month or more, and we would need permission from our supervisors to be away from our regular duties, [at this point, many candidates dropped like flies]. Eleven of us were finally selected. **Tom Almany, Sr.**, was pressed back into service from retirement; he was to work longer and harder than all the rest of us put together, and credit for much of our success goes to his tireless work and endless patience."

"[Tom's] 'right hand man' was Jerry Lata; along with Terry Wong, they did the complex scheduling of our duties, and managed to get our radios working so we could do our thing for traffic control. The [other] enthusiastic [volunteers] came from Traffic Operations'

Branch: Earl Fritcher (who had been a navigator in WWII), Nick Jones, Bob Masuda, Randy Ronning, Marty Stevens, and Ralph Thunstrom (whose son George worked full time in the TOC while his wife Gail served as a ground observer - making them a total Caltrans' Olympics family!) Three of us were pilots: Ed Anderson from R/W Utilities, Alex DeVorkin from Legal. and [me] from Project Development."

"We would fly for two days and spend one day on the ground in the TOC as dispatchers for our colleagues in the air. Our Helicopters were civilian aircraft under contract to the Department of Defense. The base of operations was Los Alamitos Armed Forces Reserve Center. We would not wear the fire retardant suits unless we wanted to... I had my own flight suit, and I sewed Caltrans patches on it. It was fun to watch military personnel on the base scan my 'insignia' before deciding whether to salute."

"On our first day, we met with people from Hillcrest Helicopters of Lewiston, Idaho - Jerry and Gale Wilson were the father and son owners/pilots of the company. The [other] pilots were Sam Barnes, Bob Bartels, Hal Kolb, Steve Rowe, Bob LaPrarie, Tom Springston, and Mike Fergione. For two weeks we practiced our routes and incident reporting procedures while the radio communications bugs were worked out. [I found it] fascinating to watch the Freeways progress from morning congestion to afternoon free-flow, mixed with truck accidents, and back to the evening snarls. [For] those of us who had taken the excellent traffic classes at the Materials Lab, it was like watching the manuals come to life."

"In those weeks before the games began, our preparations were diligent, [and] we became a dedicated team. Pilots from other localities [also] took a lively interest in the freeway system and how it did - and sometimes didn't - function. When the games began, the training and effort

paid off. Every one of the observers has stories to tell. Most of them revolve around hairy accidents and dealing with other agencies in the complicated and constantly changing airspace regulations [above L.A.]. In addition, we all had the occasional satisfaction of being able to report in a motorist in trouble and summon aid."

"We sometimes flew with observers from the City of L.A. Traffic Department, and gained insight into the interaction of State Highways and City Streets. As [most] everyone will remember, the projected gridlock and massive traffic jams predicted for the 1984 Olympics never materialized. The most interesting day was when Route 91 was closed to accommodate the bicycle races. Seeing that normally-hectic route totally deserted was amazing. When the games were over, all the observers agreed that their experiences brought increased knowledge back to their jobs. Many of the friendships formed that summer have lasted over time. Sadly, Bob Bartels, one of [our] pilots, was killed while crop dusting the following year."

"As for me, the experience was so 'addictive', I went on to learn how to fly helicopters and ultimately got a Commercial Helicopter Pilots License. For years I hoped that someday I might use those skills to help Caltrans in some way. It would have been a way to repay Caltrans for a rewarding and educational experience. Now I'm retired, as are most of the other observers. [Although it has been many decades since] the 1984 Games, the Caltrans' Air Force will be [fondly remembered] and perhaps become a more widely known part of Caltrans' history."

Topsy Turvy

With new management, comes new ways of thinking... As you may have heard in this or other publications, there has been a large turnover in District 7 Management - a new Director, Carrie Bowen, a new Chief Deputy, Shirley Choate, new Division Chiefs in Construction, Maintenance and Design, Mark

Archuletta, Deborah Wong, and Jerrel Kam, respectively, plus many acting chiefs. In part, because of concerns about "entrenchment", typecasting, need for cross-training, improving upward mobility for some, and as an aid to succession planning – thwarting the anticipated "silver tsunami" due to much of the management work force nearing retirement age, a "grand" rotation on a large scale will be fully implemented by the end of March. That means, nearly all engineering-function Office Chiefs will be moving to new assignments - Project Management Chiefs are moving to Traffic and Design, several Design Chiefs are moving to Project Management, and at least one Traffic Manager is moving to Planning. As expected, this sort of upheaval has resulted in some earlier than anticipated retirements, or, moves to other agencies. Most engineering staff, local contacts, politicians, retirees, and the rest of us, will likely find their "go-to-person" is now "up-and-gone". However trite the cliché, we must agree that the only thing constant in life is change.

A Lost Opportunity Found

"Dear Friends," writes **Bill Minter**, "The name of **Buckmaster** popped up in book I read on WWII in the Pacific. An **Eliot Buckmaster** was Captain of the USS Yorktown in the Battle of Midway. That intrigued me, so I tried to track down any relation of **Stan** to that captain. I did have an inkling that **Stan** had a Navy background and I heard his dad of the Navy christened him **Stanley O.**, hence his initials of S. O. B. 'No,' **Stan** said, 'That was not accidental.' This is best I can remember of that conversation going back to 1956/7 or so. I was not able to get anywhere on the Internet myself, so I repaired to our local library. They did much better. Here is what I found out:"

"Stan was born in 1925 and passed away six years ago, at the age of 84, (same as I am now), up in Bellingham, Washington. Bellingham is north and east of Seattle. From the book, I had guessed, for the purpose of tracking, that this

"Stan had an acerbic wit and I got to see it in action from time to time in our lunch time bridge game. Betty Burris was a regular and John Burris sat in occasionally. Others, Carol Schumaker, Tom (?) ... That bridge game, in some form or other, lasted from the time I joined [the] Division of highways 'till I retired. There were others in that game, but memory isn't serving me well anymore. But this ole' guy likes to travel memory's trail."
