World Heritage Status Update for "El Camino Real de las Californias"

In January, **Benita** and I traveled north from San Diego to Aptos, which is just south of Santa Cruz on Highway 1, which gave us an opportunity to observe the recent Caltrans "El Camino Real Mission Bell Project" to install bells along designated state routes between Orange County and Sonoma.

This project resulted in placing about 585 mission bell markers along the route. The reach between the Mexican border and north through Orange County is along Interstate 5 and, since the Feds do not allow placement of such items on the Interstate, no bells were placed there.

The Caltrans program was hindered because the present legislatively designated El Camino Real state routes do not include, for instance, the routes that serve Monterey, so the major focus of government during the Spanish period is not included. The 2 million dollar installation resulted in a marker bell about every 4 minutes in the direction of travel!

At the Aptos meeting of Los Californias, I gave a talk on the El Camino Real bells and the California Mission Foundation effort to include it as a UNESCO World Heritage Site. At the February Meeting of the California Missions Foundation, **Keith Robinson**, Caltrans Principal Landscape Architect, manned a display of the above Mission Bell Marker Project.

I will continue to monitor and report on this program.

Each cone bears the name of one of the 184 Caltrans employees that have been lost. This year we will honor Oscar Vargas, a Structures Construction Engineer in District 11. It is a tribute that must be seen to be appreciated. We hope that you will be able to join us this year at any of the tributes being held, either in Sacramento on May 4th or in your own area.

In 2015 CTF donated almost \$115,900 to fallen and injured workers. Never have we needed your support more. Tax deductible donation to CTF's Fallen and Injured Workers Fund can be made A Workers at any time online or by check. Assistance Fund was recently created for Matt Crete, Structures Construction Engineer, who was seriously injured in a head-on collision on an icy Route 36 while on the way to a construction site in Lassen County. The Man I Call Coach By Gordon Analla

He's Larry McPeak, a 42 year veteran with Caltrans. I call him "Coach," after the late National Football League (NFL) coach, Bill McPeak (no relation). The NFL coach helmed the Washington Redskins for five seasons. He was renowned for acquiring personnel that later

led to championships and many of the players were elected to the Hall of Fame. He was a football lifer. That's **Larry** too. He spotted talented people, and helped them succeed in their careers with Caltrans. "My joy was seeing those that I worked with, go on to promote to Supervisors, Superintendents, and Region Managers, and to accomplish some pretty amazing things."

During Larry's distinguished career with the department he served as a Bridge Crew Supervisor. Superintendent, Hazardous Materials Specialist, and Region Manager ----a varied career from a man of varied interests. I know "Coach" as a man who encountered a great deal of mental anguish as he had to endure not only one major incident with multiple fatalities and injuries, but also another fatality, no less gut wrenching, spread apart 10 years' time. In each case, however intended, the one in charge, in this case Larry as a Region Manager, is put under the microscope. This scrutiny goes with the job and it's multitude of responsibilities. The scrutiny may not be fair but that's the nature of the job. In both cases, "Coach" handled himself with dignity, class, and compassion for those who lost family members and affected co-workers who suffered from a residual affect.

The first incident was on March 27th, 1994, a Sunday, spring morning. A clear and beautiful day that brought dark clouds over the San Leandro Region in particular, but also District 4 as a whole. At approximately 9:24 am, a truck driver crashed into a shoulder closure operation killing five people (one of whom was an 8 year old girl) and injuring multiple workers (MPROs working off their incarceration). The work operation was litter pick up and weed removal. The operation was overseen by a Caltrans Lead worker Chuck Warner (who was killed) and a Maintenance Worker. The driver of the big rig. a set of duals, was driving under the influence. His actions changed people's lives forever. One of the MPRO's had just become a Father that

morning. He was informed of that by one of the two private citizens that entered the closure in a pickup truck. The latter, driven by the uncle of the lady that gave birth, had his daughter in the pickup with him. The young girl (name withheld) exited the truck and told the young man the news. And just like that, they were both struck and killed. A moment's joy became a lifelong tragedy and sadness forever linked with birthday and death anniversaries.

An investigation commenced. Parallel to that was a decision made by "Coach" to begin the healing process. The very next day the entire Region was shut down and diffusing sessions were conducted by our Employee Assistance Program (EAP) contractors. This action by "Coach" was light years before what has now become the norm. That was Larry McPeak. He was a pioneer that believed in thinking outside the box and bringing people together to grieve, mourn, reflect, and review what transpired. Because of that incident, and unfortunately other fatalities and serious injuries that occurred during the years that followed, campaigns such as "Slow for the Cone Zone" and "Be Alert. My Parents Are At Work" were initiated. And also how such programs as the Maintenance Activity Zone Enhancement Program," Enforcement and (MAZEEP) and the Construction Zone Enforcement and Enhancement Program (COZEEP) with the California Highway Patrol on site were established. In addition, the law of "Double the Fine" in traffic zones was implemented. All these methods of trying to make the work zones safer for highway workers came about through tragedies and the efforts of those who cared and were in a position to make a difference.

As I previously mentioned Larry also had to endure another job fatality when a Structural Steel Painter (**Bill Callaway**) fell at the Benicia Bridge. Larry called me soon after the fatality. I had taken the day off to go to an Oakland A's game with my family. I could feel through the

phone line that **Larry's** heart was heavy. I then contacted the Safety Officer for the Region, and he began the investigation. I didn't get too involved with this fatality as I was only a few days away from leaving Caltrans to accept a position at SFO. But I'll never forget that phone call from Larry. It stays with me to this day.

I feel for "Coach" and that he had to experience both fatalities in his career. No one deserves it once, much less twice. But if it had to happen, Larry was the type of person that would cope with it as he did, as a professional and compassionate person. And that about sums up the man I call "Coach." - Gordon Analla

El Nino or Not?

As if to confirm the 2016 Farmer's Almanac prediction, the Orange County Register headline on February 19, claims that the highly touted El Nino rainy season has failed to materialize. So far, the few and scattered rain storms have not produced the drought busting effects we were rallied to prepare for early last fall. Southern

California has produced a scant 6 some-odd inches of rain, when a "normal" rainy season is closer to 15 inches. Unlike the 35 inches we experienced in the 2005 season, it is hard to believe the remaining months of March and April will make up the extra 9 inches to achieve a "normal" L.A. annual rainfall season.

Curcu-What?

- 3. Turmeric dramatically increases the antioxidant capacity of the body, with powerful antioxidant effects to neutralize "free radicals", and stimulate the body's antioxidant enzymes.
- 4. Curcumin boosts levels of the hormone, brainderived neurotrophic factor (BDNF), which increases the growth of new neurons and fights

- various degenerative processes in the brain, is linked to improved brain function and a lower risk of brain diseases.
- 5. Curcumin has beneficial effects on several factors known to play a role in heart disease. It improves the function of the endothelium and is a potent anti-inflammatory agent and antioxidant.
- 6. Turmeric and curcumin leads to several changes on the molecular level that can help prevent and potentially even treat cancer.

Road Last Traveled

Caltrans retiree **Greg Batey** passed away unexpectedly Dec. 23 while visiting family in Utah. Greg spent his entire Caltrans career in District 11 beginning in 1979. He worked in Maintenance, Surveys and Construction before retiring as a Transportation Engineer (Civil) on May 31, 2001. Greg returned to the District as a retired annuitant to work on special/critical assignments. He later moved to Las Vegas with his wife Carol.

We also received sad news that District 11 retiree **James R. Waters** passed away peacefully on December 28, 2015 after a battle with congestive heart failure. He was 86. Jim's career with Caltrans began in 1983 as a Heavy Equipment Mechanic at Shop 11. He moved to the District Office and held positions as Telecommunications Manager and then Building Manager. Later in his career he moved to the Planning Division where he proudly managed the elderly and handicapped transit services program for San Diego and Imperial Counties. He retired in 1993.

The father of five children, **Jim** was preceded in death by his wife and two sons. He is survived by his two daughters, **Beth Landrum** and **Pam Waters**, their spouses, children and grandchildren. **Beth** works in the District 11 Planning Division.

Honorary **QCC Member** and former D-11 District Director **William "Bill" Dotson** passed



away Friday, February 19th at the age of 94. He had served as the District 11 Director for San Diego, Imperial and east Riverside counties from 1983-1988.

Bill was featured last year in an historical video entitled "Caltrans District 11 Directors - The Interchange of Innovators," found at https://www.youtube.com/watch?v=1_n0P4rtUBs.

At **Bill's** retirement celebration in 1988, former Caltrans District 11 Public Information Chief **Jim Larson** said that Bill Dotson was "a universally respected engineer and administrator running what is generally regarded as the most efficient and trouble-free of the Caltrans' 12 districts."

He began his 41- year career with the state of California in 1947 as a Junior Civil Engineer with the then "Division of Highways." Bill graduated with a Bachelor of Science degree in Civil Engineering from the California Institute of Technology and became a licensed Civil Engineer. He later received a degree from Carnegie-Mellon University in 1973 Advancements continued in following years through various assignments in District 11 including serving as Deputy District Director for Development Project and Principal Transportation Engineer.

Much of the construction work under Bill's tenure covered rehabilitation and reconstruction of interchanges to bring them up to current design standards for the time. He focused on replacing highway lanes and adding shoulders. He was very proud to have worked on the San Diego-Coronado Bay Bridge. He was also involved in the planning stages for the Interstate 15 High Occupancy Vehicle Lanes.

Design on San Diego highways—Interstates 5, 8 and State Route 163—took place under Mr. Dotson's supervision. Construction on State Route 52 (SR-52) from the Interstate 805 separation to San Clemente Creek was



completed in 1987. The portion of SR-52 from Convoy Street to Santo Road opened in May 1988. This new segment completed a 9-mile long link from Interstate 5 to Santo Road. That same month.

construction began on the first of several projects totaling 18 miles to widen State Route 78 from four to six lanes between Oceanside and Escondido.

According to Caltrans archives, Bill's tenure as District Director came with challenge and opportunity. District 11 was project ready but short on people. He was tasked with reorganizing the district to develop the projects and hire staff to fill the needs—65 hires were made in the first year of reorganization. Many of these hires are still working in Caltrans.

Bill is survived by his wife **Dorothy**, and two grown children, **Janet** and **James**. Our heartfelt condolences go to the family, friends and those who worked with him.
