### CALIFORNIA TRANSPORTATION FOUNDATION

The California Transportation Foundation (CTF) has established several Assistance and/or Memorial Funds to assist Caltrans workers and/or their families through difficult times recently. If you wish to donate to any of these funds, you may go to <a href="www.transportationfoundation.org/donate">www.transportationfoundation.org/donate</a> and click on the name of the fund listed on the drop-down menu.

The Foundation has established the "District 2 Caltrans Fire Victims Fund" to benefit the 11 District 2 transportation workers who have lost their homes and possessions because of the Carr fire. Donations are tax deductible and will help these employees recover from their devastating loss.

There is also the "District 1 Caltrans Fire Victims Fund" to provide assistance to two transportation workers from District 1, one of which lost their home and another who suffered losses associated with being evacuated due to the Mendocino Complex Fire.

CTF is matching dollar-for-dollar up to \$5,000 for the "Mazon Assistance Fund." Mr. Jose Mazon,

an injured worker from District 11, was struck by a DUI driver while he was parked on the left shoulder removing debris. Mr. Mazon is currently recovering from head and body injuries.

The Foundation is also matching donations dollar-for-dollar up to \$5,000 for the "**Peter Marzano Memorial Fund**." Mr. Marzano, a fallen worker from District 9, was crushed by the concrete truck he was driving when it rolled over while delivering concrete to a construction site.

The "**D. Fagorala Assistance Fund**" has also been established to collect donations to help with funeral expenses for two Caltrans District 4 workers whose son, Dakarai Fagorala, was killed in a car accident in Walnut Creek recently. CTF will not be matching donations to this account.

Another Fund that has been established is the "Caltrans District 7 Headquarters' Fallen Workers Memorial Signage Fund." Donations to this fund are needed to cover the costs of the signage that will be installed to remind and forever commemorate the deaths of 31 fallen Caltrans workers who lost their lives while working to keep the roadways safe for the traveling public in Los Angeles and Ventura Counties. CTF will be matching these donations.


she also became the first female reserve officer, as she proudly served the Yuba City Police Department.
