and bring them to the meeting. Don will line-up a speaker for the next meeting.

# The Haps in District 7

his HAPS section is dedicated to Caltrans environmental planner Leonard Cornett. He was a dedicated volunteer at the Railroad Locomotive Historical Society's Rail Giants Train Museum at the Fairgrounds in Pomona CA. His special project was the care and maintenance of "Big Boy Steam Locomotive 4014," a static display at the museum.

First, you need to know the story of this steam locomotive. Here is information straight from the Union Pacific website.

'Twenty-five Big Boys were built exclusively for Union Pacific Railroad, the first of which was delivered in 1941. The locomotives were



132 feet long and weighed 1.2 million pounds. Because of their great length, the frames of the Big Boys were "hinged," or articulated, to allow them to negotiate curves. They had a 4-8-8-4 wheel arrangement, which meant they had four wheels on the leading set of "pilot" wheels which guided the engine, eight drivers, another set of

eight drivers, and four wheels following which supported the rear of the locomotive. The massive engines normally operated between Ogden, Utah, and Cheyenne, Wyo.

There are seven Big Boys on public display in various cities around the country. They can be found in St. Louis, Missouri; Dallas, Texas; Omaha, Nebraska; Denver, Colorado; Scranton, Pennsylvania; Green Bay, Wisconsin; and Cheyenne, Wyoming.

Big Boy No. 4014 was delivered to Union Pacific in December 1941. The locomotive was retired in December 1961, having traveled 1,031,205 miles in its 20 years in service. Union Pacific reacquired No. 4014 from the RailGiants Museum in Pomona, California, in 2013, and relocated it back to Cheyenne to begin a multi-year restoration process. It returned to service in May 2019 to celebrate the 150th Anniversary of the Transcontinental Railroad's Completion.' [Source Union Pacific website]

So now the D-7 connection from **Marie Martin**. When the anniversary of the driving of the Golden Spike was imminent, Union Pacific got the idea to resurrect their largest steam locomotive for the commemoration event near Promontory, Utah. Twenty (Five) Big Boys had been built, but U.P. selected the one in Pomona due to the fact that **Leonard's** diligent maintenance had kept it in the best shape of all the surviving Big Boys across the country.

The train has been traveling since the Promontory Point celebration and was offering excursion rides in Southern California. Caltrans retirees **Daria Simolke, Bob Walters** and myself, **Marie Martin**, in addition to Bob's son, **Jason**, rode the train from Barstow to Colton Yard on October 13. It was an amazing journey. Rail fans by the hundreds were on the train, and by the thousands were lining the entire route as we passed by. The onlookers had everything from cell phones to huge professional cameras on

tripods set up to record the event. Scads of cars raced alongside accompanying us wherever a road ran nearby. Many people just stood and waved. We passed by a couple of Freeway interchanges and traffic was at a standstill in all directions as motorists gaped at the huge huffing anachronism overhead and the Highway Patrol were tearing their hair out.

Unfortunately, **Leonard** died in 2007 and did not live to experience his dream of seeing Big Boy



4014 restored to full operation. Sadly also, our longtime rail fans and traveling buddies, Caltrans co-workers **Kirsten** and **Stewart Stahl** have also gone to the Big Rail Yard in the Sky. All of them were much missed on this adventure. We made up

badges commemorating **Leonard's** achievement (see above ) and took a photo of the Stahls with us, so all were there in spirit.



Our good friend and colleague, **Bob Watkins**, sends his recollection of a 1982 Caltrans Haps in District 9. **The Right Thing** follows:

The small town of Bishop California can be isolating at 4000 feet elevation with mountains towering to 14000 to both the east and the west. There is no rail line and only one highway, Hwy 395, which climbs to 8000 feet north of town. In 1982 I was the district director for the highway department, known as Caltrans, and my wife, Janet, was the county school superintendent for all of Inyo County.

Some way we got the idea of a GED class for Caltrans workers. (Generalized Education Development or Certificate of High School Equivalency) We found a retired teacher from Los Angeles who was anxious to teach a formal evening class with study material provided by the state.

But there was a problem. The state was willing to pay for the tuition but the maintenance workers were required to do it all on their own time and travel. The workers were stationed at yards miles away the district office. For example, the Shoshone yard was 220 miles on the other side of Death Valley, over four hours away.

We had a strong response to the announcement. Twenty four men signed up for the evening classes which was held in the district office cafeteria. They came from the mountains to the north and the desert to the south. I attended the first meeting and to no one's surprise in the parking lot was several orange pickups. Time and travel? I just looked the other way.

For the last class the state sent a proctor to give the GED test. Twenty two took the test and all past. (They had lots of practice tests.) Then came the precious part. On Saturday we had the graduation in the cafeteria. All twenty two attended. The room was full of kids and families. There was an outburst of joy as their fathers, sons or husbands, one in his fifties, received their GED certificates. There were tears and hugs and excitement that could only be found at a high school graduation. One gray haired mother had come all the way from Pico Rivera in the Los Angeles area to be with her son and his family.

Why the big fuss over a GED? Think about how times have changed. When these men were in high school the graduation rates varied from 30 to 60% depending on the neighborhood. Were they the first in their family to reach this level? Some of these guys had worked a half day with the crew, drove for hours, attended class, drove home, got up and worked all the next day then studied all that evening. It was time to celebrate. I was sure the state had some dedicated maintenance men who through great personal effort had done the right thing and would do so in the future.

It became known that I had allowed workers travel time and the use of state pickups for these classes 15

so I had some explaining to do. I just told the director in Sacramento that I had done the right thing. - **Bob Watkins**

#### John Hood: Dine [Navajo] Artist, USMC Combat Veteran's Art is in Smithsonian

Following **John Hood's** service in the Marine Corps he attended San Diego State University. He has been employed by Caltrans as an artist and designer for most of his professional career. National recognition is being acknowledged following an assignment to create the undocumented immigration road sign.

Peter Liebhold, a curator for the Smithsonian Institution's National Museum of American History, said the museum wanted to acquire an example of **John Hood's** art in the presentation role of road sign for its permanent exhibit on transportation, which opened a year and a half ago, but curators found the 5-by-7-foot sign too large for the allotted space.

The Smithsonian settled on a photo of the sign instead. It hangs one floor down from the original 1813 Star Spangled Banner, the flag that inspired the national anthem. "It transcends its local history," Liebhold said. "Its importance is as a metaphor for undocumented immigration into the United States."

The sign is intended to warn drivers they might encounter people frantically darting across lanes of traffic as they tried to evade border security. The job landed on the desk of Caltrans graphic artist **John Hood** in the late 1980s. He was asked to design an image that, in the blink of an eye, would alert drivers to the unexpected sight of pedestrians in their headlights.

Before Hood began drawing the sign, he and his supervisors met with Highway Patrol officers and saw photos of accident scenes. What got to him most were the deaths that involved families. "Graphically, I wanted to show a family," said Hood, who lives in San Diego. He chose to

include a pigtailed girl, rather than a boy, because "there is something about a little girl running across with her parents that we are more affected by."

At first he drew detailed figures, with faces that showed "a little bit of fright." But, in the end, Hood and his supervisors decided on a



silhouette. "When you are looking through headlights, that is what you see," **Hood** said, "an outline of the image itself."

As he sketched, Hood tried to imagine the despair that might drive such a family across the border and onto a forbidding foreign highway. He drew from his own experience fighting in Vietnam, where he had seen families run for their lives as villages were attacked. He remembered stories his Navajo parents had told him about ancestors who died trying to escape as U.S. soldiers marched them onto reservations.

John Hood was born and raised on the Navajo Reservation near Gallup, New Mexico. He is named after an uncle who died as Prisoner of War in the Pacific and an uncle was a Navajo Marine Code Talker, the late Mr. James Nahkai, Jr. John graduated from a Bureau of Indian Affairs (B.I.A.) boarding school Wingate High School and as a student he Rodeoed, riding bareback broncos and bulls on the Navajo Reservation. He enlisted in the United States Marine Corps while still attending high school. Did a tour in Vietnam as combat infantryman in the late 60's and early 70's. "While serving with the First Marine

Division in connection with combat operations against the enemy in the Republic of Vietnam from 1 June 1970 to 21 March 1971, lance Corporal Hood performed his duties in a exemplary manner." He is decorated for his military service with the AWARD OF THE NAVY ACHIEVEMENT MEDAL with COMBAT "V".

The drawing was finished in a week. Even without faces, the characters conveyed a sense of urgency in their flight. "It doesn't just mean they are running across the freeway," **Hood** said. "It means they are running from something else as well. I think it's a struggle for a lot of things, for opportunities, for freedom."

The first signs were unveiled in September 1990 at Camp Pendleton. With a new purpose **John** was again in close proximity to the Marine Corps.

Hood, the Caltrans artist, a modest man by nature, didn't set out to create anything of the sort, just a road sign to help save lives. Over the years, he has watched the transformation of his simple creation into souvenir, protest art, icon and metaphor with a mix of amazement and amusement, wishing only that some of the money being made from it today were generating funds for public safety. Hood earns no royalties. He's lost track of his original sketches. His wife filed them away, but he's not sure where. Not that it bothers him. His road sign, or at least some version of it, isn't hard to find.

"That was my baby," he said." It has its own life now."
