he QCC will have elections for the statewide executive officers in March/April 2023 and the new officers will take office on April 20th. **This will be the first election in over a decade.** The QCC Constitution requires an election each year and the plan is to have statewide elections each year going forward.

Although the Constitution does not limit the term of office, except for the President, the commitment should be looked at as a one-year term. If the incumbent does not want to continue and run for reelection, that is fine and they can resign after the one-year term is up.

For the office of President, the Constitution is more specific. It states, "The President shall be elected for a one-year term but may stand for re-election. If successful in the re-election the

President cannot run for that office any further time. Any President who has served only one year in the past is eligible to run for one additional year. No person may serve as President for more than two one-year terms." One more restriction on the Statewide Officers is that they cannot also be a District Director while in a statewide office.

Candidates are needed for President, First Vice President and Second Vice President. Currently, there is one nomination for President and one for VP. It is desirable to have at least two candidates for each office. So please consider who in your District would make a good QCC President or VP, perhaps even yourself, and submit the nomination to **Mike Ogilvie**, Secretary-Treasurer. The deadline for submittal of nominations is January 31, 2023.

The duties for each position are not defined in the QCC Constitution, except for this; "The duties of the various officers shall be the customary duties attached to each office." The President presides over the Executive Committee. The Constitution states; "The responsibilities of the Executive Committee shall be to direct the affairs of the Club, authorize expenditures, and arrange for an annual audit of the financial records of the Secretary-Treasurer,

as desired." The VP's are members of the Executive Committee but beyond that have no additional defined duties.

Looking forward to seeing some great candidates stepping up as the QCC has some significant challenges to face. The March QCCer will have the election ballot for members to use for voting.

Here's how to get it posted on the Quarter Century Club website: Write your story in an email and send it to: post+speedreportsjs@coffeecup.com Your story is then transmitted to the CTQCC website where it is stored in a folder accessible only by the webmaster, who then extracts the text and pictures you sent and stores them in a private folder on the Stories page of the Caltrans District

specified by you. The webmaster then sends you an email with a link to the page containing your story, accessible only by you and the webmaster. You can then view your story on the Internet, make any changes you would like, then send them in an email just as you sent the original.

The webmaster then notifies you by email when the changes have been made. When you are satisfied with the web page containing your story, send an email to the same email authorizing the webmaster to post the story for public viewing. You can still add to or make changes to the story as described above after it is published by sending an email to the same email. Let us hear from you!

Road Last Travelled

From the Appeal Democrat on December 8, 2022:

Gordon Lee Bordsen entered this world on Sunday, January 6th, 1929 and departed December 2nd, 2022. Born to Tonder and Jennie



Bordsen of Norway, he had two sisters. He grew up on a sheep ranch in the Sutter Buttes. He entered school not speaking **English** but Norwegian. At age 14, Gordon was special given a license driver's

permitting him to drive to and from school,

because the school bus didn't go far enough to pick him up. Of course, Gordon and his Model B Ford, "drove all over California".

In 1946, **Gordon** graduated from Sutter Union High School. **Tonder**, as he was known back then, played football, basketball, baseball, was in student leadership, a member of CSF, and was active in FFA. After graduation, Gordon attended Yuba College.

Drafted into the Korean War, Gordon spent time in England building airfields. Upon returning home, Gordon met Carol Jean Herbranson and on Saturday, June 19th, 1954, the pair married in Minnesota. The newlyweds moved to Stockton where Gordon attended and graduated from the College of the Pacific (now known as University of the Pacific).

The Division of Highways, now known as the Department California of Transportation (Caltrans), in the central valley needed people with his skill set. He desired to be assigned to the Marysville office where he started as a right-ofway agent. He assessed land as part of the construction of the Interstate Highway System. Growing up on a ranch and having worked on farms gave him unique and valuable insight into the value of rural properties. Gordon helped secure the land to expand I-5 in Colusa and Glenn Counties, Highway 20 in Sutter, Yuba and Nevada counties, and Highway 99 in Butte County.

The family was active in the Lutheran church, rarely missing a Sunday. **Gordon** was an active member of the Yuba-Sutter community. He taught classes at Yuba College on Real Estate Appraisal. He was the voice of the Sutter Huskies Football for over 25 years. A passionate member of the Marysville Rotary Club, he was club President and in 1987, Rotary District Governor. In 1963, Gordon and Carol Jean became charter members of the Sons of Norway, Snowshoe Thompson Lodge.

From **Jan Johnson**: I remember playing Pinochle with Gordon and probable 14 others every day at lunch time in the cafeteria which was located in the basement of the old District 3 building. Single deck, ugh, I learned playing it double deck, quite the adjustment. Enjoyed playing with **Gordon** and the rest of the gang.

Encountering Two Miracles From The Loma Prieta Earthquake In One Day By Gordon Analla

It was a Saturday morning over a week plus from the 1989 Loma Prieta Earthquake. I had been a Safety Officer for Caltrans for over seven years. I was about to meet an employee that could have ended up dead or severely injured. He was an Engineer in the Construction Branch, who had been admitted to Highlands Hospital in Oakland earlier in the week.

I won't give his name, but the individual was injured when one evening in the dark of night he entered the remains of the Cypress Freeway. A "Ramp Closed" sign was posted along with delineation and barricades. He opened an area enough so his truck could pass through. Put the delineation back and then proceeded to drive off that highway. How far he and his truck fell, that I don't know. All I know was I saw the pictures of the truck and it landed upside down, flat as the habitual pancake. He had to have been wearing his seatbelt, and as the film "Room to Live" states, it certainly was.

He was my first encounter with a miracle that day. His injuries were not life threatening and I don't believe anything was broken. He was severely contused if there is such a thing. He looked like a professional fighter who was on the losing end of a decision or a knockout. But overall, he was okay. I didn't want to harass the individual or bombard him with many questions. This was the first time we had met. I was simply concerned for him and asked if there was anything he needed, if there was anything I could do for him.

He told me that the treatment was good and that he was going to be released soon. We did talk about the accident, but I don't remember the specifics too well. He knew he had made a mistake, and I can only imagine what he felt like when he knew what was transpiring. He did continue his career with Caltrans, and we did encounter each other from time to time. If there was any adverse action taken against him, I was not privy to it. My professional opinion, he had paid enough with the experience. I believe with my heart and soul, he simply made a mistake and paid for it dearlyhe was very fortunate that it wasn't worse.

The second miracle I encountered that day, was not so much the person, but the experience, the magnitude. After visiting the engineer at Highlands, as I exited the main lobby, it was filled with media personnel, lights, camera, action, and reporters reporting from the scene. I had no idea why they were there. I don't remember if I saw a fellow Caltrans employee or asked someone, but I learned that a Caltrans engineer, Steve Whipple, had helped rescue a man still alive after the quake. Steve was out checking the site, somewhere I believe on the Cypress. It was early morning and the adrenalin from the Earthquake had passed, and as I seem to remember it, the beginning of the day was rather mundane, if you could imagine that. Then it happened. Steve with a flashlight in hand, some

15 feet above him, noticed a person in a car. There was movement which caught his attention. The person was Buck Helms, and this occurred 89 hours after the '89 Earthquake, oh the irony. He called for assistance and Mr. Helms was taken to Highlands. That was the second miracle of that day.

The story doesn't end happily. Unfortunately, despite valiant efforts by the medical staff and the gentlemen himself, Mr. Helms succumbed one month and one day after the quake. But so amazing that he battled, that he lived, that he held on, all that time. That was the great takeaway of the human spirit.

Steven Whipple was one of nine members from the Bay Area that were recognized for their efforts during the Loma Prieta Earthquake and were given the honor of throwing out the first pitch(es) of game number three, the resumption of the World Series between the Giants and the A's. Way to go Steve. A very quiet gentleman.

(Gordon Analla: I always thought this of the devasting earthquake. I believe because the Giants and A's were playing or tried to play the game, it saved many lives. As I feel that many fans headed home early to catch the 5:05 start time on television. It is surely something the way certain things in life work out. Don't you think?)

appy Holidays! It's mid-December, and we've just had our first big storm. Highway 1 has been closed twice in Monterey County due to slides and falling rock. Power outages, flooding, fender benders, etc. are keeping our Maintenance folks busy. Locally, a huge tree fell in the plaza at the Old Mission, but fortunately no pedestrians were affected.

Good news for travelers driving between San Joaquin Valley and the Central Coast: The CTC has approved funding for a \$171 million project to improve the Cholame "Y" junction of Rte 41 and 46. The intersection will be replaced with a flyover connection to transfer eastbound traffic on Rte 46 to northbound Rte 41. Ground breaking will happen next March, and work is expected to take three years.

A pilot project to improve traffic flow on Rte 101 near Pismo Beach would widen the inside shoulder into a part-time travel lane on weekdays. Concrete barriers separating N/B and S/B lanes will gain about 10 inches in height. This has met with some resistance from local officials because it will obscure views of the coast. Other parts of the project include a park-and-ride lot on Price Street and extension of the shared use path in Shell Beach.

Thanks to **Barb Ronimus**, a former D-5 employee, I've enjoyed seeing several articles about our district from the CSAA book "California Highways" by Ben Barlow, published circa 1920.
