Route 66 Centennial-2026

The 100th anniversary of Route 66, with its eastern terminus in Chicago and its western terminus in Santa Monica, will be celebrated in

2026, according to Public Law 116-256, adopted on December 23, 2020 as an Act of the Senate and House of Representatives of the 116th U.S. Congress Assembled, known as the "Route 66 Centennial Commission Act¹."

The Act stipulates that the President of the United States shall appoint a

commission composed of 15 members, as follows: 3 members based on the recommendation of the Secretary of Transportation; 8 members, one from each state through which Route 66 passes, at the recommendation of the Governors of Illinois, Missouri, Kansas, Oklahoma, Texas, New Mexico, Arizona and California: and 4 members based on each of the recommendations of the Speaker of the House of Representatives, the Minority Leader of the House of Representatives, the Majority Leader of the Senate, and the Minority Leader of the Senate.

Paraphrasing, the Act states that "Route 66 was the first all-weather highway in the United States connecting the Midwest to California, and has played a major role in the history of the United States, becoming a symbol of the heritage of travel and the legacy of seeking a better life shared by people of the United States, having been enshrined in its popular culture [through songs, books, and other media]; that the year 2026 will be the centennial anniversary of Route 66, and that the commission shall recommend in a report to Congress activities that are fitting and proper to celebrate that anniversary in a manner that appropriately honors the Mother Road of the United States."

From the County of San Bernardino website², "Route 66, also known as "the Mother Road", "Will Rogers Highway", or "the Main Street of America", was constructed in 1926. However, the road's origins travel back in time (to 1912) before it was paved as one of the country's first transcontinental highways, the "National Old Trails Road³".

The road has served the country well as families left the Dust Bowl and headed west to California during the Great Depression; moving troops and supplies during World War II; and becoming a destination itself to travelers seeking freedom of the open highway. Today, in excess of 250 miles of National Trails Highway (Route 66) can be found in the County of San Bernardino and the County Department of Public Works maintains nearly 150 miles from Needles to San Bernardino ..., And although Route 66 is no longer a main route across the country, it is a national treasure to be preserved and enjoyed for generations to come.

The information on [the County] website pertains to the reach from the easterly edge of Nebo Street in Barstow to Mountain Springs Road/I-40 entrance. This section of the roadway has 128 timber bridges that were built more than eight decades ago, and all are displaying the negative impacts of many years of weather, flash floods, truck traffic, erosion, earthquakes, animal life and other factors. By reconstructing and rehabilitating the aging bridges, the safety, vitality, historical preservation, and accessibility of one of America's greatest treasures will be reinstated."

Below is information for the CTF fund that has been established for **Quanda McGadney**, Caltrans Maintenance Worker, who tragically lost her life recently. Here is a memo from the Caltrans Director to all Caltrans staff.

Dear Caltrans Staff,

It is with a heavy heart and great sadness that I must inform you of the loss of one of our Caltrans family members today. **Quanda McGadney**, a 51-year-old Caltrans Maintenance Landscape Worker in District 4, was struck by a hit and run driver this morning while working on Interstate 80 near Vacaville in Solano County. She succumbed to her injuries at the scene. The driver was apprehended by CHP and is in custody.

Quanda served the State of California for more than 18 years and has been with Caltrans since 2018. She is survived by her nine-year-old daughter, Nairobi, and her two sisters, Priscilla Stevenson and Candice McGadney.

Our sympathy and our heartfelt prayers go out to **Quanda's** family and all those who worked with her. She had many close friends within her work group, and Caltrans is providing support to her family and co-workers as much as we possibly can. While there is no blueprint for processing difficult news such as this, it would not be unexpected for you to be experiencing a wide range of emotions and reactions. I encourage you to reach out, support one another, and find your place for solace, including taking advantage of our department's Employee Assistance Program (EAP), if you feel the need to talk with someone.

To help Quanda's family at this difficult time, a memorial fund is being established through the **California Transportation Foundation**. Details will be forthcoming.

The webmaster then sends you an email with a link to the page containing your story, accessible only by you and the webmaster. You can then view your story on the Internet,

The webmaster then notifies you by email when the changes have been made. When you are satisfied with the web page containing your story, send an email to the same email authorizing the webmaster to post the story for public viewing. The Haps in District 4

B rian White writes, "My wife, Terri, and I sold our 32 year old home in rural Petaluma and relocated to Pendleton, OR one year ago. Our older daughter lives in this town with her husband and son. Our younger daughter, expecting a baby soon, lives with her husband and daughter in Portland, about 3 hours drive from here.

"We have decided to spend our sunset years closest to those who matter most: our girls and grandchildren.

"I keep in touch with those who were close to me in D4, but the staff has changed so much since I retired 11 years ago I don't think anyone would know me. I still retain a lot of institutional knowledge from my years in Drafting Services and my experience as the overseer of the Office of Business Management but nobody ever asks or is interested once you walk out the door."

Ed Coble writes, "This situation came to mind as I was thumbing through the June 2021 QCCer and saw a District 8 announcement that Alberto Vergel de Dios had been promoted to a Senior Engineer position and had received his BS degree from the University of Santo Tomas, Manila, Philippines. This reminded me that two of our engineers, Joe Browne and Frank Pappa, also spent time at this university during WW II as enemy non-combatant prisoners of war by the Japanese occupation."

"Joe Browne's family was living in China until the Japanese invasion in the 1930's. They moved to the Philippines and were caught there at the start of WW II.

"**Frank Pappa** and family were also in the Philippines. Frank's father had purchased a plantation and intended to live there.

"Both families and other civilian non-combatants were incarcerated in the compound of the University of Santo Tomas in Manila.

Here is the story of **Joe Browne** (District 4 Director 1993 – 1997) as related by Joe:

"It has been over 75 years since we were liberated from the camp, but the memories are still vivid. The camp lasted 38 months from 1942 to 1945. **Frank** Pappa's family and mine were there for the entire period. Frank and I were about the same age. We played soccer together."

"The most vivid memory is that of being hungry all the time since the meals (mostly beans and rice) were not very filling. I weighed 70 pounds at liberation (normally weight over 100 pounds). The two foods we missed the most were milk and bread. My mother cleaned the bathrooms to earn money for extra food such as eggs. The camp held several thousand people from several different nationalities who were caught in Manila when WW II started."

"We children were very fortunate the teachers in the camp started a school for us. The academics were so good that I skipped the 9th grade when we returned to the USA in mid-1945."

"Frank and his wife Jean both passed away in 2015. Joe ad his wife, Patty, are enjoying their retirement in Lincoln, north of Sacramento."

The granddaughter of **Charles Maloon** informed the **QCC** of his passing away in January. Charles was a recent proud contributor to the **QCCer** as he wrote about celebrating his wedding anniversary with his high school sweetheart, **Yvonne**, who he met in 1945 and married in 1950.

Finally, here is another story from Gordon Analla.

A Unique And One Very Fortunate Individual By Gordon Analla

The man walked at warp speed. Perhaps he thought that way too. Hard to say. The few words that he spoke, were staccato in nature. Not a tall man. The type that was always one of the first in the yard. He would put the coffee on. Always wore short sleeve Caltrans issued Idaho orange shirts . . . even when there was a morning frost or snow in the upper peaks. He was always there for callouts. I'm sure he wasn't a California native. A twinge or twang of maybe mid-West, or Macon-Dixie lineage.

He was the type of person . . . a giving person. He had a good heart and would donate vacation time to those in need. He was gullible and his personality was the type to be used for other people's advantages and purposes. That was a sad part of his persona.

He was involved in two of my most head scratching personal injuries in my 22-year career as a Safety Officer for Caltrans. Fortunately, in both instances, neither were of serious nature, though they very well could have been far more serious and even fatal.

The first one involved a Lead Worker who filled up two iced tea bottles with an herbicide. The individual then put them on the crew room table near his locker as he changed and prepared to take them home. The subject of this piece, must have been thirsty and reached to grab one and guzzle it down. The Lead worker informed him what it was. This only stopped him temporarily. As he opened up one of the bottles and took a big gulp from it. Almost immediately he became ill. During my post-accident investigation, no one ever stated that he was encouraged to take a sip. It seemed he acted alone. What did happen was he was taken to the emergency room with the Poison Center being Control notified.

Fortunately, he was released that same day. He didn't suffer any other ill effects.

The second instance involved a shoulder closure on an off-ramp. The closure was not yet put in place, as he prepared to help with that process. He exited the truck he was driving, a two yard, on the driver's side, the hot side of traffic. He was hit and run by a vehicle as soon as he got down. He was taken for emergency treatment at a nearby facility. I went to see him at the hospital within an hour of him being hit. His Supervisor was also there. The subject told me he exited the vehicle but that he was facing traffic. I don't think he thought he was lying to me. Perhaps he had his adrenalin going or what. I looked at his overalls and then it hit me! On his lower back and behind on the left side and on his left pant leg, also on the back, were imprints of the brand of the tire, and much of the pertinent information that is on a tire. It was amazing that he wasn't more seriously hurt. Someone, something, karma, was looking out for his benefit that day and the other instance. I should have given him the nickname of "Mr. Lucky," as he certainly was.

I can't honestly state that I and the above employee were close. But I did like him. He was what he was. No frills. A guy like other people I encountered in other Regions and in fields of life. I hope he's having a great retirement and I wish him the very best.

I think this is a suitable quote applicable to this man. It is from the baseball and buddy film, 'Bang the Drum Slowly'. "He was not a bad fellow. No worse than most and better than some. And he wasn't a bad ball player when they laid off him. From here on out, I rag nobody."

As far as the Lead Worker taking the product home, I didn't have any input in that part of the investigation. That was between the Region and Personnel. I would be a liar to state I never did anything like that. I am sure most of us did.




After the army, Bill returned to San Diego and
