### **Thomas E. Stanton First President of the Caltrans Quarter Century Club in 1939**

Thomas Elwood Stanton was born and raised

in Los Angeles. He graduated from Saint Vincent's College in 1899 with an A.B. degree. He then attended the University of California at Berkeley where he received a B.S. degree in mining.

He began his professional career in the City Engineer's Office in Los Angeles in 1905, where he served successively as instrument man, chief of party and as assistant engineer in charge of sewer

and paving design and construction. In 1912, he accepted the position of Principal Assistant Division Engineer in Fresno by J. B. Woodson, the new Division Engineer of the California Division of Highways.

In 1914 he advanced to the position of Principal Assistant Division Engineer in Sacramento. In 1920 he was made Assistant Highway Engineer in charge of general inspection throughout the southerly portion of the State. In 1921, when the Department of Public Works was formed, Stanton was appointed Assistant State Highway

Engineer until his appointment as Materials and Research Engineer in 1928, which position he occupied for the succeeding 23 years until his retirement in 1951.

Stanton was probably best known for work on the durability of Portland cement concrete. Mr. Stanton was the first to discover that one of the most marked forms of deterioration in Portland cement concrete was attributable to an internal reaction between constituents in the cement and in the aggregate. In other words, certain brands of Portland cement may contain small percentages of alkalis which cause no trouble unless the sand used contains certain minerals such as opal or similar forms of silica which will react with the alkalis in the cement.

During his professional career, Stanton was an active member of a number of American technical societies. He was a director of the American Society of Civil Engineers, 1937-39, and vice president in 1942-43. He served on the Board of Directors of the American Concrete Institute in 1943-44 and was elected an honorary member in 1955. Together with other honors for notable contribution, he was awarded the Wasson Medal by the American Concrete Institute in 1934, and the Norman Medal by the American Society of Civil Engineers in 1943, both for outstanding work in Portland cement concrete, especially for the discovery of the alkaliaggregate reaction.

We are saddened to announce the passing of CTF Founder Heinz Heckeroth who passed away on Sunday, March 6. The California Transportation Foundation was founded in June 1988 by former Caltrans Chief Deputy Director Heinz Heckeroth. Mr. Heckeroth had recently retired from Caltrans and wanted to create a charity that would give back to the Caltrans community he dearly loves. He envisioned a non-profit that would one day be able to expand to serve private sector and other public transportation agency employees as well. Mr. Heckeroth served as the Foundation's first executive director and recruited a dedicated board of former Caltrans employees.

**Heinz** and **Hope** Heckeroth endowed the H. Heckeroth Scholarship for university and college undergraduate students majoring in civil engineering, interested in pursuing a career in transportation after graduation, and who were affiliated with Caltrans (interns, volunteers, student assistants, employees). Mr. Heckeroth was always a champion of the students who participated in the CTF Transportation Education Symposium and would personally introduce himself and meet with scholarship recipients at our CTF Transportation Forum and CTF Transportation Awards every year.

Will Kempton, CTF Board Member said, "No words can express the dedication and commitment this man had to his profession and to the field of transportation. Even after his retirement, Heinz wasn't finished he created the California Transportation Foundation, an organization of incredible people that has grown and thrived over the years. He leaves an unmatched legacy and he will be missed."

Today, CTF is a respected 501 c(3) charitable foundation with a diverse board that is ready to help the transportation profession. CTF will be here for years to come, testament to the legacy of **Heinz Heckeroth** – remembering those we've lost and aiding those injured in the job, recognizing achievement in transportation and educating the next generation of California transportation professionals.

The webmaster then notifies you by email when the changes have been made. When you are satisfied with the web page containing your story, send an email to the same email authorizing the webmaster to post the story for public viewing. You can still add to or make changes to the story as described above after it is published by sending an email to the same email. Let us hear from you!

It is with great sadness that we inform you of the passing of D8 Metro Region Maintenance Manager II, **David "Dave" Wood**. Dave passed away on Sunday, December 19, 2021.

The beginning of Dave's successful career with Caltrans Maintenance started almost 24 years ago in 1997 with D8 North Region as a Caltrans Highway Maintenance Worker. With hard work and determination, a series of promotions followed. He promoted to Caltrans Equipment Operator II in May of 2000. In January of 2003 he promoted to Caltrans Highway Maintenance Leadworker. Two years later in December of 2005 he promoted to Caltrans Maintenance Supervisor of Fawnskin Maintenance. **Dave** lateraled briefly to D6 Shaver Lake in 2006 then lateraled back to D8 Essex Maintenance in 2007. He was promoted to Caltrans Maintenance Area Superintendent of D3 Sutter Sierra Region in 2010.

The latest issue of the *CT News* includes two District 4 obituaries. For those who do not read the *CT News*, here they are:

**Richard "Dick" Gee,** retired Caltrans engineer and District 4 Director passed quietly at home on Christmas evening after a several decades battle with Parkinson's disease. **Dick** was born on Sept. 30, 1931, in Canton, China. His father brought his family to the United States in 1938 and started their life in San Francisco. They lived in North Beach where



Dick grew up with his siblings. He attended Mission High School in San Francisco, then went onto UC Berkeley and obtained a Bachelor of Science degree in civil engineering.

Through the draft, **Dick** served in the Army and spent time in Alaska working on helicopters. After his service, he obtained a master's in public administration from Golden Gate University though the GI Bill.

His professional career brought him to the world of infrastructure and transportation. Dick spent over 25 years at Caltrans, working his way up through various assignments and ascending the leadership of Caltrans District 4. His projects included Interstate 580, Interstate 680, Highway 380, and the 92/101 interchange.

In 1981, a once-in-a-lifetime opportunity came his way. Legislation had been past in Sacramento allowing San Mateo County to consolidate 11 separate transit agencies into the San Mateo County Transportation District – SamTrans. This turned into his professional passion – serving as the District's first Engineer/Deputy General Manager of Planning & Engineering. He worked at SamTrans for 12 years. He received a "Tranny Award" from the California Transportation Foundation, and in a letter from Congresswoman **Jackie Speier**, **Dick** was recognized for his "expertise in public works, rail and bus transportation to construct a mobility blueprint for San Mateo County for 2005 and beyond."

Along with helping start SamTrans, he worked on a number of major infrastructure projects including the Colma BART station, SamTrans' North and South Bases, and the peninsula commuter rail - Caltrain. He retired from SamTrans in 1993.

Aside from his passion for transportation, he was passionate about his family. He loved his wife– Helen, his love for 64 years. Helen loved him right back, being his caregiver for decades, until her health told her that she needed help.

He and his wife raised four children: Jeff and his wife Judie, Tara and her husband Brian, Susan and her husband Ed, and Eric and his wife Lonnie. He was blessed with nine grandchildren: Christopher, Elizabeth, Jacob, Edward and his wife Amala, James and his wife Sara, Alyssa, Brandon, Carly and Daniel, and four great grandchildren: Tristen, Isabella, Callie and Luna.

Bob Dayton Tucker, retired Caltrans maintenance worker died of natural causes,



peacefully at home, with family by his side. He was preceded in death by his loving wife, Joan, and his parents, Sid and Mary Tucker.

**Bob** was born in Paso Robles and grew up during the Depression and WWII years. He enjoyed playing,

hunting, fishing and being with his siblings, Sam Tucker, Mary Cornwall, Chickie Godsey and Cliff Tucker. He graduated from Paso Robles High School and entered the U.S. Marine Corps during WWII. After his Honorable Discharge in 1948, he returned to Paso Robles. A rancher at heart, he worked with local ranches and harvesting crews. He also worked for the Farmers Alliance, as a letter carrier for the U.S. Postal Service, and in the oilfields of Standard Oil.

Bob married the love of his life, Joan Daniels, in 1952. They had two sons, Russ and Doug. They loved their life together for 63 years. He now joins her for eternity.

**Bob** began a new career in 1961 with the Division of Highways, now Caltrans. He began as a Maintenance Worker II in Hollister, then El Centro, and finally, Half Moon Bay, where he became foreman. Through hard work, night school and excellent mentors he became region manager of San Jose territory. There, he was in charge of employees, equipment and the recovery of roads and infrastructure after the Loma Prieta Earthquake in 1989. He retired in 2000 with many commendations and statewide recognition.

**Goro Endo**, age 91, passed on June 12, 2020. Wes Lum was a good friend and colleague of Goro's. He has provided the following remembrance after consulting with **Ray Higa**,

#### Chuck O'Connell, and Janet Muramoto.

I met Goro in 1984. Since we are both from Hawaii, our friendship was immediate and long My responsibilities brought me to lasting. District 7 often. District 7 was a pioneer in Freeway Operations (aka congestion management) from the 60's. In those early days District 7 addressed congestion and safety with Ramp Metering, Changeable Message Signs, Freeway Service Patrol, Incident Detection and Incident Response. The "42 Mile Loop" was an important test section of freeways (I-10, I-110, and I-405) that helped evaluate these systems before applying them throughout California. Goro was a leader and expert in the development of Ramp Metering and freeway traffic analysis (critical in evaluating these improvements). He was a "can-do" employee who helped with the success and growth for many of these projects. In 1987 he managed the Pathfinder Project where the public was able to drive a brand new Oldsmobile (from a fleet of 25) for a week. Their evaluation of the electronic vehicle mapping system helped Caltrans and auto companies understand how technologies could assist drivers in the future.

Goro's ideas influenced many aspects of congestion management we experience every day. His efforts to easily provide Caltrans traffic flow information to radio and TV stations is automatic today. He was also part of the Smart Streets Project that coordinated Caltrans and Los Angeles City traffic signals to minimize congestion for motorists in daily traffic, incidents, and events. **Goro** even assisted me in HQ with co-authoring Budget Increase requests to the Governor's Office for equipment and personnel for these projects.

Most people did not know of Goro's work and accomplishments. Most only know of his kind, soft-spoken voice, and his helpful, can-do approach. He was a classic guy and real benefactor to all who drive the freeway system. As a friend, **Goro** often accompanied me to meals on my visits to the District. He'd join me for breakfast in the produce market, round up the gang for lunch somewhere (J Town, Korea Town, etc), and accompany me to dinner. After his retirement I continued to visit Goro and **Amy** during my business and personal trips to SoCal. One trip in 2014 was for the Dedication of the TMC to **Dick Murphy**. At the event he and I were able to visit with many colleagues. Goro was swapping Freeway Ops stories with **Paul Chow**, **Al Iwamasa**, **Gary Graham**, and **Ray Higa**.

#### **Dear Caltrans Family**

I am very pleased to report that today the Federal Highway Administration (FHWA) announced new apportionments for its national bridge program, an historic initiative made possible by the recent passage of the Bipartisan Infrastructure Law.

The program is the largest investment ever made in American history to fix bridges, dedicating \$26.5 billion to the states and \$825 million for Tribal transportation facilities over the five years of the law.

FHWA confirmed that California will receive \$4.2 billion over five years, more than 15 percent of FHWA's total national bridge program budget! California will receive nearly \$850 million this fiscal year.

This is exciting news and an especially excellent way for Caltrans and our state's communities to begin the New Year of 2022.

#### Congratulations!

Item of interest from **Tamie McGowen** on January 25, 2022. In a move applauded by both environmental organizations and the construction industry, today Caltrans announced that we have issued new standard specifications approving the use of low-carbon cement by our contractors in building and maintaining California's transportation system.

Because cement is the "sticky" ingredient that holds concrete together, Caltrans uses the material extensively. In 2017 alone – the latest year we have data – Caltrans used 325,000 tons of cement to make concrete, which released approximately 283,000 tons of CO2 into the atmosphere. By using low-carbon cement, we can cut these emissions by up to 10%, which is equivalent to taking more than 6,000 cars off the road!

This very good news is another example of Caltrans' profound and ongoing commitment to Climate Action, one of the three foundational principles. Thank you to all who made this possible!

Here is a copy of the above article:

**John Beaton** began his service with the Division of Highways in 1929 as an Engineering Aid. He later worked for the Bridge Department until after World War II when he transferred to the State Personnel Board. He returned to the Division of Highways Design Department. He was named State Equipment Engineer in 1963 and then in 1964 was appointed Chief of the Materials and Research Department.

Topics covered include Kings River Canyon job and working with Camp 39 convict labor, participated in survey of county-built bridges when a large number of county roads taken over by State in 1933. Worked with J. W. Vickrey to reorganization/expansion devise plan for Division of Highways to meet requirements of Collier Burns Act of 1947. Recruited junior civil engineers from out of state in 1950s. Worked at Materials and Research Lab under Francis Hveem, laboratory fire of 1956. Welded construction of bridges, use of T1 Steel for Carquinez Bridge, utilization of prestressed concrete on bridge building, initiation of dynamic testing of guardrails/crash tests using radio-controlled automobiles and Governor Hiram Johnson's legacy of noninterference by in the operations politicians of State Government.

Caltrans Retiree **Dick Wehe** passed on the last day of 2021, New Year's Eve. His obituary accurately describes his life and can be located at:

Jeanne Scherer states: Dick graduated from U.C. Hastings School of Law, at San Francisco and started his legal career with the Caltrans Legal Division in Sacramento in the early 1970s. For his first ten years Dick was assigned primarily eminent domain cases in support of the department's expansion of California's highway system. For the next two- plus decades Dick specialized in dangerous condition of public property and negligence tort cases. He was a founding member of the "tort fort"— a group of sometimes rowdy but always dedicated trial lawyers in HQ Legal responsible for defending the state in complex, multi-million dollar tort cases.

Dick quickly earned a reputation as one of the pre-eminent public entity trial lawyers and was a formidable opponent in the courtroom against many of the top law firms in California. He excelled at developing comprehensive litigation strategies and worked closely with maintenance employees and engineers to be effective witnesses on behalf of the department. Dick's ability to explain complex legal and engineering concepts in layman's terms, combined with a humble and self-effacing personality, enabled him to develop trust and rapport with judge and juror alike.

Dick's contributions to Caltrans extended beyond his courtroom success. A natural born leader, Dick quickly assumed a leadership role in Caltrans Legal, first as a team leader and later as the Chair of Legal's Committee for Tort Liability and Risk Management, responsible for the development and oversight of statewide legal policies relating to client tort risk management issues and litigation practices. He worked closely with the Divisions of Maintenance, Traffic, and Design. His commonsense approach to risk management issues resulted in the development and implementation by divisions to reduce the department's tort liability. He taught at numerous internal training academies and for many years was a favorite instructor at the Kingvale Maintenance Academy, sometimes even riding his bike from Sacramento to Kingvale to teach class. When Dick retired in 2004, he was the Assistant Chief Counsel for Torts/Risk Management. His litigation skills resulted in the successful defense of hundreds of lawsuits, saving Caltrans millions of dollars.

Dick was proud to be a Caltrans attorney. He exemplified the finest attributes of the legal profession and was dedicated to public service. He influenced a generation of up and coming Caltrans trial attorneys and provided them the tools to carry forward his legacy with exemplary legal skills and integrity. - Jeanne Scherer

My friend, **Dick** and I met in the Caltrans HQ locker room in 1982 while preparing to bike home. He was one of a couple dozen regular bike

commuters — mostly Caltrans — who utilized the locker room and showers. Dick and I lived in the same neighborhood, Arden Park, and began 20+ years of commuting together.



Over the years we biked to work — rain or shine in freezing and stormy or heat wave weather. We thought extreme weather a challenge. On 110degree days he would phone me at 2:00 to remind me to hydrate. We'd step into the shower in our bike clothes to wet them for the 10-mile trip home. On stormy days when car traffic was hindered by flooding or dark traffic signals our bike trip was faster than driving. Each year we'd bike over 4,000 miles together.

Dick was an initiator for many fun activities, which included: having a beer at the Rest Stop bike accessary shop on the trip home; planning evening beer tasting events; exploring Sacramento restaurants for lunch; comparing restaurants for the Best Hamburger; establishing a Hiking/Biking Club; and organizing our trips.



**Dick** was the best friend one could have. Always thoughtful, kind, and caring. One didn't have to ask, he was there to help. Dick was a dedicated family man and a true partner to his wife, Aleda — evidenced by their daily walks and jointly prepared gourmet dinners. Dick Wehe will be missed by his family and many friends. -Wes Lum

The CTF Founder **Heinz Heckeroth** passed away on March 6, 2022. The following information comes from the CTF website: <u>https://www.the-ctf.org/our-story</u>

**Heinz Heckeroth** retired in 1988 after 33 years of State service. In his early career with the City of Los Angeles, he was Project Design Engineer on the East Los Angeles Interchange. His career in the Department began in District 7 in 1955 and steadily advanced in positions of responsibility in Distict 7 and Headquarters, including Deputy Director for District 7, Chief Deputy Director for Resource Management, and participating in the planning for the creation of Department of Transportation. After his retirement, he founded the California Transportation Foundation.

Two of the main activities (among many others) that are part of the CTF's mission are helping Injured and Fallen Workers and the Transportation Awards.

Injured and Fallen Worker and Emergency Relief (IF&ER) Fund program was established to help California all transportation industry employees and their families who are in need of financial assistance because of death, injury and natural disaster. The program was established to aid employees during crucial times when quickly available funding is critical to meet the sudden costs of emergencies.

There are three categories. One is the Fallen Worker Grant that helps families of fallen transportation workers killed in the line of duty. Another is the Assistance and Memorial Fund for workers who have been injured while on the job and families of fallen workers. CTF matches these private donations up to \$7500. Lastly, Emergency Relief Grants are given to Transportation workers who have lost their home due to natural disaster. Each year CTF awards the coveted Transportation Awards to the top project teams in 14 categories. They also recognize "the Big Four": Person of the Year, Elected Official of the Year, Organization of the Year, and Project of the Year.

The CTF Transportation Awards are held annually and this year will be on May 26, 2022 in Sacramento.
