### A SINGING HIGHWAY AGAIN!

# From the Side Pocket

week after I retired from Caltrans in July of 2022 I drove from San Bernardino to Chicago and back on as much of Route 66 as I could fit into a two-week trip.

In Albuquerque, I visited Dr. Roger Zimmerman, New Mexico's representative on the Team to nominate Route 66 as a National Historic Civil Engineering Landmark. I had talked previously with Dr. Zimmerman about the possibility of

getting New Mexico's Singing Highway restored as an attraction for the 1926 Centennial.

The Singing Highway is located a few miles east of Albuquerque in Tijeras Canyon, an un-inhabited area where the external noise from a rumble strip won't be bothersome to residents.

As a side-note Caltrans District 8 is experimenting with sinusoidal "mumble strips" with a project on SR-210 that have the potential to reduce external noise to a level that is less intrusive than the noise from conventional rumble strips. https://dot.ca.gov/programs/environmentalanalysis/noise-vibration/rumble-strips The musical rumble strip on Route 66, constructed in 2014, is currently not functional due to traffic wear and tear, but I'm hoping that it can be restored in time for the 2026 Route 66 Centennial. I'm working with the Route 66 Road Ahead Partnership to obtain funding for a restoration project. While I was in Albuquerque, Dr. Zimmerman and I met with the contractor who built the rumble strip, Frank Sanchez, at San Bar Construction, and talked about the history of the construction project. Frank put me in touch with the two men at National Geographic who did the musical design, and the three of them and myself

> have since communicated on Zoom about the proposed restoration.

> Of all the YouTube videos that have been posted by people who have driven the Singing Highway, the best musical quality that I've heard is the one posted by the Smithsonian Magazine: "If You

**Linda Supernaw** added that a few days after the District 8 Summer Luncheon in July, <u>The Sun</u> <u>Telegram</u> ran an article about the "Musical Highway" on the historic Route 66 in New Mexico.

The article states, 'The New Mexico Department of Transportation and National Geographic Channel hired a contractor that designs and builds traffic control devices to engineer a stretch of Route 66 that literally plays "America the Beautiful" when cars drive over it at 45 mph. There are also a handful of other musical highways elsewhere in the world, including one in Lancaster.

Smithsonian Magazine explained this was accomplished through mathematical equations and a series of perfectly spaced rumble strips. Engineers figured out how the distance of each strip affected the pitch that was produced when a tire drove over it.

All of the sounds and music notes that we hear in day-to-day life are just vibrations through the air. For instance, anything that vibrates 330 times in one second will produce an E note - a guitar string, a tuning fork or even a tire the article states.

Once the spacing was figured out, metal bars were welded together to make a template and the templates were pressed into heated pavement to create a freeway tune."

The webmaster then sends you an email with a link to the page containing your story, accessible only by you and the webmaster. When you are satisfied with the web page containing your story, send an email to the same email authorizing the webmaster to post the story for public viewing. #### Santa Cruz Maintenance Yard, Primo By Gordon Analla

One of my regions when I first became a field Assistant District Safety Officer in District 4 was the San José Region. Back then, in 1983, the Santa Cruz territory was part of San José. During my 22 plus years as a safety person with Caltrans, I encountered many great people. I have to state, that one of my favorites stops was the Santa Cruz Yard. I never felt that I had to prove myself to any of the crews. This coming from a young man from The City, and also the District Office. They always went out of their way, to make me feel welcome. There was a certain vibe there, unlike any other yards/stations. I didn't feel like an outsider. I think they were just happy to see someone from the District Office make the long trip down there.

There was an instance when a money carrier vehicle nearly penetrated their closure. This was brought to my attention during a safety meeting. After the meeting I got the information that was needed and I sent a letter to the company. Within a few days, I received a positive response from their management and relayed that to the crews first by a phone call, and then presented them my correspondence and the reply in person. Larry Walker was the Regional Manager then. A bear of a guy, but just a down to earth homespun person who slapped me on the back when I presented him the correspondence with an "atta boy!" It meant the world to me. And it meant acceptance. I believe it showed all involved that I would follow through.

One of my favorites times was going down Highway 1 from my home in Pacifica to Santa Cruz. I loved being near the ocean. It was a great stretch just to get away. Many times, the reason for me going down that highway was to do an operation field review at Waddell Bluffs. The residents of the yard kidded me with "if the boulders don't get you, the great whites might." This was one way traffic control as they paved and/or removed the boulders and the rocks from the travel way.

There was one particular gentleman, who was the Landscape Supervisor. His name was **George Dunn**. A prince of a guy whom, I didn't work with and for him too long, but long enough to know that I respected him immensely. He had a medical condition which, sometimes his arms moved involuntarily or shook. And his speech to some might be hard to distinguish. This man showed me strength. And he was a good Supervisor and nice person to boot. I don't know what happened to him, but I am sure he retired due to health matters. But what an amazingly, knowledgeable, helpful individual he was.

That yard, that area, to state again, were some of the best people I have ever encountered at Caltrans. Jim Walters was the Superintendent. There was Richard Barnes, Don Saunders, Lead worker; Leon Juan, " Watsonville All-Star" Manuel Ramirez, Dale Williams, Tree Crew Supervisor; Bob Pierce, his Lead worker; Dale Grav, Roger Hope, and Lester K. Jennings, Lead worker. I labelled him "the great shark hunter," as he told me of a tale when he was out in the ocean, and a scene like in the movie "Jaws," was his experience. Greg Mahoric, Landscape Supervisor; Cindy Cocoli. Keelee Adams. Floyd Schultz. Roger Willenberg; Landscape Supervisor Tom Gamblin, who was raised in my neighborhood in The City; Chris Rodrigues, Tim Fleck, Larry Culver, Al Zonio, the very helpful and cheerful Resident Mechanic. There was a Travelling Mechanic, a young man in his late twenties or so, that travelled with his dog. I loved it. And of course, good man James McMahan.

As the years past like post miles travelling down the highway, my fond memories of this group always bring a smile to my face and a spring in my step. Thank you one and all for the way you treated me.

Future projects may include the much-needed expansion of Rte 101 in the Pismo Beach area, construction of a bridge over Rte 46 East at Union Road, a roundabout adjacent to Rte 101 South at Avila Road, another roundabout on Rte 154 at the intersection of Baseline Avenue and Edison Road, and improvement of pavement, lighting, and signs on Rte 183 near Salinas and Castroville. An overhead wildlife crossing is being planned over Rte 101 in San Benito County in the Rocks Ranch area to reduce collisions with animals.

Travelers on Rte 101 between San Miguel and King City should note that the speed limit is being reduced from 70 to 65 mph along that stretch, to help eliminate fatalities and serious injuries.

# The Haps in District 8

I n July we had our last Summer Luncheon at Hannah's Restaurant as they are retiring. We had a great time visiting and an informative talk about what is going on with Route 66 Celebration planned for 2026 from **David Bricker**. He also informed the QCC that plans are in the works for a 100-year anniversary for District 8 (opened in 1923) for some time in October. Received an e-mail from **John Reed** (longtime Division of Highway employee) as follows:

"Before I cork off, I'd like to beat my own chest about rumble strips - yep, the recessed grooves in the shoulder of the westbound Baker grade approaching Baker (if they're still there).

We (the Traffic Dept) were undertaking studies to see if we could wake someone up before they ran off the road. We had already placed raised bars (we'd call them speed bumps now) along a short stretch of the eastbound shoulder before reaching Baker but running over them at any speed was more disconcerting than alerting.

I didn't exactly invent rumble strips, but I noticed that our Maintenance Dept. had scored the road with tread marks several times in the mountain areas where they had to move a Caterpillar tractor from one side to the other. The 'Cat' tracks made my car vibrate without causing any loss of control. So (Traffic) got in touch with the RE on the job that happened to be starting westbound on the Baker grade and suggested that he pad one side of 'Cat' treads and run the unpadded tread down a stretch of newly laid asphalt shoulder to create depressions in the shoulder near the edge of traveled way - the RE did us one better and welded some pipe like bars to a metal wheel and used it to create even depressions (similar to the 'cat' tracks) in the outside shoulder as they laid the asphalt. No additional materials, no raised anything to interfere with driving or plowing snow, and they rumbled great.

I did an 'after' study (it had **John Chadoin's** name on it) and came to the conclusion that there was a slight, but significant reduction in 'run off road' accidents in that area. Some math student reviewed the study later (in the '90's, I think) and found no significant reduction, but he used the chi square test, Gary Nelson told me. [I don't believe that is a proper statistical method for evaluating rare - such as 'run off road accident' - events. For example, you can't use it to determine the likelihood of being struck by lightning very well.]

By that time I'd long transferred out of Traffic, and just knew that rumble strips were picked up by other states in some form or other.

Thanks for keeping us posted with 'Division of Highways' (Oh! You say it's 'Caltrans' now?) information. (This was a jab at the 50<sup>th</sup> Anniversary of Caltrans news!)" – **John Reed**

**Lance Hinek** stated that he worked with Frank in the mid 1980's when Frank was Deputy District Director of Right of Way for District 09 and his boss.

The following was taken from the Funeral Service:

**Frank Crosby "Sammy" Hoyt, Jr.** passed away peacefully in his family home in Laguna Woods on January 30, 2023 surrounded by his wife Elizabeth "Betty" Hoyt and many other immediate family members. Known as "Cubby"



as a boy, Frank grew up in Eagle Rock and later in Long Beach with his father Frank Sr, mother Nonnie, sister June, grandfather Royal Hoyt, grandmother Catherine Brady, later with his stepmom Lois, as well as many other

relatives and friends in a very loving and caring family.

Frank attended Naples Elementary and Rogers Jr. High, where he first met and courted his bride to be, Elizabeth Mae Linde. He went on to Wilson High School and enrolled in Aviation Shop where he worked on real airplanes for 2-3 hours a day. It was during his years at Wilson where he was given the nickname of Sam, or Sammy, which remained with him for the rest of his life. He graduated early from Wilson and was drafted in June 1943. After completing officer and flight training, Sammy graduated as a 2" lieutenant on June 27, 1944, at Luke Army Airfield in Arizona. He married his sweetheart, Elizabeth 'Betty' Linde on February 23, 1945, in Phoenix, Arizona, with Betty's parents in attendance. Despite his desire to help the war effort as a fighter pilot, Sammy was never called to serve abroad due to the surrender of Japan in August 1945. Sammy was discharged from the service in October 1945 and went to college on the Gi Bill. Upon graduation he went to work for the Division of Highways.

After his family, Sammy loved flying more than anything. He was able to enlist as a reservist in the 303° Air Rescue Squadron and flew many missions including to Spain and Hawaii. He also found a way to own and fly his own plane for many years out of Long Beach and later Mammoth where he was a member of the Mammoth Air Force flying club.

Sammy loved the outdoors and shared that love with his kids as they grew up on many camping trips to Yosemite and other destinations. He led his kids on so many hikes, including summiting Mt. Whitney. Sammy also found time to be a scout leader and teach his kids outdoor living skills and to follow scout values such as being "trustworthy, loyal, helpful, friendly, courteous, kind, cheerful, thrifty, and reverent." Sammy shared his love of travel and adventure by taking the family to Spain in March 1964 to go to school, learn Spanish and see sights caravanning around Europe. That experience taught the family to appreciate other cultures and nationalities. The many people they met in Europe were invariably friendly, helpful and kind to the Hoyts.

The family returned to the US in July 1965 to a new home in Costa Mesa which served as a launching pad for the children as they completed school and went off fo college. In 1978, after ski trip to Mammoth, Sammy and Betty moved to Mammoth where they lived until 2013. During the many years in Mammoth, Sam and Betty skied, fished, played bridge, and traveled extensively with family and friends to many destinations in the US and abroad. They also owned a Bounder RV which Sam and Betty drove all over the country.

Sammy, a patriot through and through, loved the USA dearly. All his life, he loved to fly the flag. Sammy never tired of watching WWII movies or documentaries, He also loved watching sports with Betty or with his kids until the day he died. He was an avid reader as well, and especially treasured books that had to do with flying, WWII or both. Sammy was a devout Catholic from the time of his birth and lived a life that was honorable, calm, even tempered, decent, generous, fair, and friendly. He smiled and laughed easily.

He\_was a great storyteller and loved to tell a joke. He liked to cook pancakes for the grandkids and paella for guests. He loved to mix sangria, martinis, or a gin and tonic for grownups. Steve made huge contributions to the Central Coast Railway Club, the National Railway Historical Society and other organizations through participation in excursion planning and operations, bus services, content for publication, preservation of artifacts, and presentations. Many successful train excursions were the product of teams of volunteers that included Steve and his expertise and enthusiasm for passenger trains."

He remains in the memory of many including his family and friends.
